

2022 Resolutions passed by Board of Directors

1. Resolved that the By-laws as per January 9th, 2023, draft, be submitted to the membership at large for approval and adoption.

3. Resolved that Volunteers putting up lawn signs for shows, be refunded a portion of their gas costs within the following policy:

When lawn signs need to be installed by someone who does not live on the route, it is proposed to pay some gas expense: Based on my car that consumes 7.2 litres per 100 km and the price of gas at \$1.75.

- 50 km or less total \$10.00
- 51-100 km \$15.00
- 100-150km \$20.00

4. Resolved that Show registration refund policy be:

Arts Carleton Place will attempt to compile a waiting list of vendors; however, the following will apply regardless of whether a waiting list does or does not exist at the time of your withdrawal.

- 1) Withdraw 45 days prior to set-up day for medical reasons: 85% refund
- 2) Withdraw 30 days prior to set-up day for medical reasons: 50% refund
- 3) Withdraw 15 days or less prior to set-up day: no refund except if a replacement can be found.

5. Resolved that, to attract more visitors from Ottawa, \$750 be spent on 12 reusable banner signs to be strategically installed in Ottawa the prior to the shows and that a modest radio campaign costing around \$775 be undertaken with Rebel Rock 101.7 for the spring fine art show.
